## DISPATCHER/CARRIER AGREEMENT

The Purpose of this Agreement is to create a document whereby Named Carrier authorizes LANE QUEST UNIVERSAL LLC, to act as dispatch and to secure and/or locate loads for Named Carrier from time to time. LANE QUEST UNIVERSAL LLC will send and receive all necessary paperwork, including accepting and signing all required forms on behalf of Named Carrier.

It is Agreed and Understood by Both parties that Named Carrier will process all billing. LANE QUEST UNIVERSAL LLC will not bill any shippers on behalf of Named Carrier.

It is agreed that Named Carrier will compensate LANE QUEST UNIVERSAL LLC for each load secured and/or located for Named Carrier that is successfully loaded on Named Carrier's equipment, at a rate of \$ **9%** per load. It is understood that all loads secured via DIRECT shippers will be at a rate of **9%** per load per week. It is understood by both parties that LANE QUEST UNIVERSAL LLC will invoice Named Carrier each week for all loads accepted by Named Carrier and Named Carrier will remit payment to LANE QUEST UNIVERSAL LLC upon receipt of invoices.

It is Agreed and Understood by both parties that, as a result of failure to remit payment to LANE QUEST UNIVERSAL LLC as per this Agreement, all activity on behalf of Named Carrier will cease and request for payment will be placed in collection. It is also agreed that if LANE QUEST UNIVERSAL LLC must use collection procedure/agents, Named Carrier will bear all collection costs, including reasonable attorney fees.

This Agreement is a continuing agreement until cancelled by either party upon written notification. This Agreement may not be assigned without written consent of other party and shall be governed by the laws of the state of \_\_\_\_\_.

No amendments can be added, nor any item deleted from this agreement unless in writing and agreed to by both parties, signified by notarized copy to each party.
